INTRODUCTION

Jody Hice is currently a Republican Congressman serving Georgia's 10th District. He began life called to preach and as he grew in ministry, he supported many politicians who followed Christian values. Jody and a group from Barrow County posted and then fought the ACLU to keep the 10 Commandments in the Barrow County Courthouse.

Gary Smith met Jody through Alliance Defending Freedom, when he and 32 other pastors flew in the face of the IRS's "Johnson Amendment" which was used to withhold tax-exempt status from churches who endorsed a candidate from the pulpit. They have not been challenged by the IRS to date. Jody eventually followed a calling and then ran for office, and won a seat at Georgia's 10th District, and believes that Business, Home, Church, School are all important to KINGDOM WORK.
